**PERMIT APPLICATION REVIEWS**

- Shoreland Permit Application (RSA 483-B) NHDES File Number: 2024-01922. Subject Property: 27 Shirley Park Road, Goffstown, Tax Map #35, Lot #12. Construct a 24x36 (846 sq. ft.) post & beam frame garage on a concrete slab. West side of property 70 ft. away from existing house and 100+ feet away from water's edge. **PRLAC Comments:**

- The Committee noted that it appears that the existing gravel driveway is not being included with the post -construction impervious area calculations.
- The Committee also makes the following recommendation
  - Given proximity to the river, the Committee recommends that if property owners choose to fertilize, that they only use low- or no-phosphorous slow-release organic fertilizer.
  - Recommend the use of wildlife friendly erosion control fabric and materials.
  - Reclamation seeding and plantings should use only native species, and any reclamation should avoid bio-solid based products.
- Shoreland Permit Application (RSA 483-B) NHDES File Number: 2024-03062. Subject Property: 180 Elm Street, Goffstown, Tax Map #36, Lot #78. Remove the old walkway to the dock and replace it with stone and gravel.

**PRLAC Comments:**

- **The Committee recommends that DES update the Shoreland Permit Application – Section 11 “This project is *not* within one-quarter mile of a designated river.” To language that would be more inclusive, as some may not realize that Glenn Lake is part of the Piscataquog River, which is a designated river.**
- The Committee discussed the permit application received from the applicant, its completeness and how it was received. The committee recommends the Chair, when notified of a permit application, reach out to all interested parties to inform them as to the requirement to send the PRLAC a complete application by mail, as per Env-Wq 1406.13.
- No design plan was provided, so the Committee is unable to determine the distance between the improvements and the shoreline.
- The Committee also makes the following recommendation
  - Given proximity to the river, the Committee recommends that if property owners choose to fertilize, that they only use low- or no-phosphorous slow-release organic fertilizer.
  - Recommend the use of wildlife friendly erosion control fabric and materials.
  - Reclamation seeding and plantings should use only native species, and any reclamation should avoid bio-solid based products.

**OLD BUSINESS:**

- South Branch, New Boston - illegal stream impoundment.  
Donna commented that there appears to be a beaver dam being constructed in the location of the illegal stream impound.

- Piscataquog River Management Plan (PRMP).
  - Jane reported that SNHPC submitted the 604 (b) letter of intent to DES on September 13<sup>th</sup>.
  - Donna reported that she met with the town of New Boston to review the current management plan and how it overlapped with the Town's policies and ordinances. Donna was happy to report that most of the goals in the Management Plan aligned with existing town requirements.
