- Eversource, NHDES application #2024-01739.
Gary provided the committee with an update on the Deering Planning Board's decision as it relates to Eversource application #2023-01739 and its impacts on a town owned parcel with a conservation easement. The PRLAC reviewed this permit application at its March 2024 meeting.
- Piscataquog River Management Plan (PRMP).
 - Jane informed the Committee that DES received our letter of intent (LOI) to update our River Management Plan and have invited the PRLAC to submit a complete 604 (b) Grant application.  - Jane and John are meeting with the Southern New Hampshire Planning Commission on December 4th at noon to discuss the formal application process. All Committee members are invited to attend.

- Piscataquog River Dams.
Andy provided the Committee with an update. The Goffstown River Advisory Committee has invited a representative in from NH Fish and Game to educate them on the Merrimack River fisheries. The Goffstown River Advisory Committee continues to meet and monitor the situation with the state-owned dams along the Piscataquog river in Goffstown. The next meeting is December 18th at 6:00 pm at Goffstown Town Hall.
- Goffstown Pedestrian Bridge (Goffstown Rail trail).
The Goffstown Pedestrian Bridge Committee continued to work on applying for the NHDOT Transportation Alternative Program Grant (TAP). They will be seeking a letter of support from the PRLAC.
- The Friends of the Piscataquog River Park.

Jane commented on the success of the Friends of the Piscataquog River Park. The FPRP has hosted several river clean-up events. Jane hopes to attend a general meeting.

NEW BUSINESS:

- Jane requested that John Magee to be the point of contact for all DES permit applications going forward. Jane will reach out to DES to inform them about the change.
