### **Meeting #304 August 15, 2023 MINUTES**

#### **MINUTES:**

The minutes of July 18, 2023, were approved as written.

#### **PERMIT APPLICATION REVIEWS**

- Shoreland Permit Application (RSA 483-B) NHDES File Number: 2023-01920. Subject Property: 142 Elm Street, Goffstown, NH, Tax Map #35, Lot #52. Remove existing camp and replace with new house. #### **PRLAC Comments:**

- The Committee request that the applicant verify the statement in the letter to the NH Natural Heritage Bureau, dated 4/7/23, stating “The proposed house will be 2” further away from the reference line of Glen Lake, and **will only increase the footprint by 45 square feet.** In looking at the plan provided, dated January 12, 2023, it would appear that the footprint of the new home is increasing significantly in size.
  - The Committee noted that there are many slopes within this scope of work in close proximity to the Piscataquog River and would like to emphasis the importance of the notes on the plan, dated January 12, 2023, stating that 2805 s.f. of buffer will be maintained as follows:  
“Within this area native vegetation, exclusive of lawn, shall be allowed to grow without cutting, limbing, trimming, pruning, mowing, or similar activities as needed for renewal or to maintain/improve plant health.”
  - The Committee recommends the use of wildlife friendly erosion control fabric and materials.
  - Reclamation seeding and plantings should use only native species and any reclamation should avoid bio-solid based products.
- Shoreland Permit Application (RSA 483-B) NHDES File Number: 2023-02127. Subject Property: New Boston Road, Goffstown, NH, Tax Map #33, Lot #17. Construct a 3,211 s.f. duplex with attached garages, decks, driveway and septic system.
