**MINUTES:**

**PERMIT APPLICATION REVIEWS**

The Committee reviewed the following permit applications:

- David Vermokowitz, 211 Elm Street, Goffstown, NH, Map 36, Lot 36. Shoreland Permit #2022-02845. The project proposes to construct a 1,613 s.f. building addition and a new system. The committee had no comments.

**CORRESPONDENCE/GENERAL DISCUSSION:**

- Jane commented on the two pending ARM grant proposals
- Town of Goffstown, 274 Elm Street, Goffstown, NH, Map 5, Lot 15-3, Glen Lake Permit by Notification (PBN), #2022-02869. Impact 1,300 square feet of bed and bank in order to repair a town owned 57-foot by 12-foot wide boat launch along frontage on Glen Lake in Goffstown.

Andy provided an overview of the PBN request for repair to the boat ramp on Glen Lake.

Keith noted that the State recently allocated grant funds to help communities maintain and repair public boat ramps. See GOVERNOR AND EXECUTIVE COUNCIL September 21, 2022 meeting agenda item #70, Authorize to accept and expend \$2,052,050 in American Rescue Plan Act and State Fiscal Recovery Funds for the Municipal Boat Launch Investment Program, which would provide awards to local governments seeking to improve municipally-owned boat launches located in NH. This is an allowable use of ARP SFRF funds under Section 602 (c)(1)(A) to respond to the public health emergency or its negative economic impacts. **100% Federal Funds.**

**OLD BUSINESS:**

- Jane provided the Committee an update on riverbank stabilization along the Piscataquog River on Bass Island. The City of Manchester will seek to apply for funds to stabilize the shoreline on Bass Island Park. Jane will continue to monitor.
- The Committee will continue to review the existing By Laws and the new By Laws template. If changes are recommended the Committee will seek a vote.

**NEW BUSINESS:**

The Chair asked the Committee if there was interest in updating the PRLAC logo found on the DES website

**MEMBERSHIP:**

Keith Erf reported that the Weare Select Board has recommended his nomination to the PRLAC. Keith will follow up with them to ensure his nomination gets to DES.
