**MINUTES:**

The minutes of July 19, 2022 were approved.

**PERMIT APPLICATION REVIEWS**

The Committee reviewed the following permit applications:

- Neil and Barbara McQuid, Weare NH , Shoreland Permit #2022-02286. The Committee did not receive the full permit application. The Committee only received Sheets 1 of 1, dated July 7, 2022, Sheets 1 of 2 and 2 of 2 dated August 1, 2022. The Committee requests that the applicant submit to the Committee the full complete permit application to be reviewed at our September 20th meeting. The Committee is concerned about any the increase in impervious area within the 50' buffer.
- David Letourneau, Goffstown, NH, Wetland PBN #2022-02222. The Committee discussed the Permit by Notification process. No comments on the application.

**CORRESPONDENCE/GENERAL DISCUSSION:**

The Committee discussed an email received from a Goffstown resident about erosion on Glenn Lake and how it relates to the lake drawdown and use of the lake. Andy will reach out to the resident to get more information and update the Committee.

**OLD BUSINESS:**

- Protected River sign installations, Manchester - Jane would like to reach out to the City of Manchester about improvements to the general area. Jane will then seek to formulate a plan with them, and once complete order four more signs to be install on Main Street in Manchester.
- Riverbank stabilization and debris removal project along the Piscataquog River near and on Bass Island. Jane will meet with the Director of Park for Manchester, to see if they can get involved.
- Factory Street, Goffstown - No new updates
- Middle Branch, New Boston - potential habitat destruction. A small stone wading pool dam had been constructed in the river. John will continue to monitor.

**NEW BUSINESS:**

- Gregg's Falls hydroelectric dam drawdown - The Committee discussed the proposed Glenn Lake drawdown to inspect the Gregg's Falls dam. The Committee requests that any additional correspondence about the Gregg's Falls drawdown be sent to the Committee as a stakeholder.
- Andy presented to the Committee the new By Laws template Tracy had shared with him. The Committee will review the existing By Laws and the new By Laws template. If changes are recommended the Committee will seek a vote.

The Committee discussed the need to map out a plan for increasing member. Specifically, for Weare.
